

DEED OF GIFT EXPLANATION

The Deed of Gift is a formal, legal, agreement that transfers ownership of, and legal rights to, the materials which you as a Donor are conveying to the Rutgers University Libraries to be administered in accordance with their established policies. The Deed of Gift constitutes the transfer of title and serves to define the terms of the transfer. The materials irrevocably become legal property of Rutgers University upon signing of the Deed of Gift.

Donation of Gift. The "Description" portion of this section will be completed by a Rutgers University Libraries representative. The Description of the donation will describe the materials being transferred and date received on site.

Appraised Value: Rutgers University and the Rutgers University Libraries CANNOT by law provide monetary appraisal of collections. Please consult a qualified appraiser or your accountant and/or lawyer for advice.

Disposition of Materials: In order to make the most effective use of resources, the Rutgers University Libraries reserve the right to determine the disposition of donated materials and are authorized to dispose of any materials that, in its sole discretion, it determines are no longer necessary to the collection. When a gift is received with a copy of an appraisal, items not added to the collections will be retained for two years as required by the Internal Revenue Service.

Terms and Conditions: Although most Donors will have no need to limit access to materials which they are donating, the option of placing reasonable restriction on access to the materials or a portion of the materials is available to a Donor. The Associate University Librarian for Collection Development and Management or his representative will be happy to discuss the terms of restrictions with a Donor. Any restrictions on access mutually agreed to will be for a specific period of time and will apply to all researchers.

Copyright Interests: Because assignment of copyright is often complex, Rutgers University Libraries staff is happy to work with the Donor to clarify questions of copyright control. Copyright in writings and original creations contained in a donated collection is controlled by the individuals who or organizations which created them unless the copyright has been conveyed legally to the Donor or other party.

If you, as Donor, control the copyright in all or some of the materials being donated, please check the first box in this section of the Deed of Gift and explain the extent of your copyright control. If you, as Donor, do not control copyright in any of the donated material, please check the second box. If you have any information about the holder of the copyright, please check the third box and supply as much of the requested information as possible. If the copyrights are controlled by multiple rightsholders, please check the fourth box.

Copyright Conveyance: The Rutgers University Libraries encourage Donors to transfer any copyright they may control to the Libraries whenever possible. Copyright ownership by the Rutgers University Libraries facilitates use by scholars. If you wish to do so, please initial the first paragraph in the "Copyright Conveyance" section of the Deed of Gift.

Assignment of copyright may be conditional. For example, a Donor may wish to stipulate "Copyright retained during my lifetime" or something similar in the "Limitations" space provided on the Deed of Gift.

DEED OF GIFT

I, the undersigned Donor, hereby donate and convey to the Rutgers University Libraries, all rights, title, and interests that I possess, other than copyright interests which are discussed below, in the following materials (the "Materials"):

I understand that the location, retention, cataloging, and preservation of the Materials, or other considerations relating to their use or disposition are at the discretion of the Rutgers University Libraries in accordance with its access and use policies and standard collection practice. These donated Materials shall be preserved, organized, and made available for education and research in accordance with the Rutgers University Libraries processing and access principles.

I agree that at the discretion of the Rutgers University Libraries, the Materials, in whole or in part, may be reformatted for preservation purposes. To the extent that I hold copyrights in the Materials, I agree that the Materials may be transcribed or digitized and made accessible to all persons qualified to use the Materials in the Rutgers University Libraries as well as beyond the library, subject to any terms and conditions stated below.

Terms and Conditions:

In the event that the Donor may, from time to time, hereafter give, donate, and convey to the University, for inclusion in the Rutgers University Libraries, additional Materials, title to such Materials shall pass to the University upon their delivery, and all the provisions of this instrument of gift shall be applicable to such additional Materials. A description of the additional Materials so donated and delivered shall be prepared and attached hereto and incorporated herein.

Copyright Interests:
